**Manufacturer's Certification Statement**  
Pertaining to the  
American Recovery and Reinvestment Act of 2009

This Certification Statement provides you the taxpayer the documentation necessary to verify that certain products manufactured by **TrimLine Windows, Inc., Ginkgo Industrial Park, 50 Louise Drive, Ivyland, PA 18974** meet the eligibility performance criteria for the tax credits identified in the American Recovery and Reinvestment Act of 2009.

**Qualifications for Tax Credit:**

The American Recovery and Reinvestment Act of 2009 provide federal tax credits for "Eligible Building Envelope Components" that improve energy efficiency. In order to qualify for the tax credit a TrimLine window product must have a "U"-Factor of less than or equal to .30 as well as a Solar Heat Gain Coefficient (SHGC) rating of less than or equal to .30 and has been purchased and "placed in service" between January 1, 2009 and December 31, 2010. These values apply to all climate zones in the United States and can be verified by the NFRC label attached to each window. These new standards are much more stringent than those allowed for previous tax credits for Energy Star rated window and door products. Qualifying products meeting the performance requirements as outlined above are eligible for tax credits of 30% of the product cost of window and doors up to \$1,500 on your federal income tax return.

**TrimLine Windows, Inc. Qualified Windows / Doors:**

The TrimLine window products set forth below satisfy .30 U-value and .30 SHGC performance requirements as stated above when purchased with TrimLine's Comfort Plus Low-E glass with argon or argon/krypton gas blend. Qualifying products which otherwise meet the performance requirements will not meet the necessary ratings when purchased with the internal spacer bar option available with Simulated Divided Lite muntins. Simulated Divided Lite muntins without the spacer bar WILL meet the .30/.30 performance requirements.
